Young person's agreement

- I will be responsible for my behaviour when using the internet, including social media platforms, games and apps. This includes the resources I access and the language I use.
- I will not deliberately browse, download or upload material that could be considered offensive or illegal. If I accidentally come across any such material I will report it immediately to the group leader.
- I will not send anyone material that could be considered threatening, bullying, offensive or illegal.
- I will not give out any personal information online, such as my name, phone number or address.
- I will not reveal my passwords to anyone.
- o I will not arrange a face-to-face meeting with someone I meet online unless I have discussed this with my parents and/or teacher and am accompanied by a trusted adult.
- If I am concerned or upset about anything I see on the internet or any messages that I receive, I know I can talk to any responsible adult.

I understand that my internet use at Corrie Primary and Nursery School and during any Remote Learning undertaken at home will be monitored and logged and can be made available to the teacher/teaching assistant. I understand that these rules are designed to keep me safe and that if I choose not to follow them, Corrie Primary and Nursery School may contact my parents/carers.
